

Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Work experience in lift DWS should be 5 years with in the last 10 years. It is also same for JV form.
 - Form should have minimum Two work experience(similar Nature) in lifting of water at a vertical head 240m, water flow 2.5ltr/sec & 45000 ltr/day(in case of 15HP pump & 11KW inveter).
- 3.Bids document must be submitted to the Kumakh Rural Municipality Office, Salyan on or before 31th days, 12:00 PM. Bids documents shall be sealed in an envelope addressing to the Kumakh Rural Municipality Office, Salyan indicating name of the contract, contract identification number, bidder's name and address.
- 4. Sealed Bids document shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 PMof31stdays (2078/01/28)at Kumakh Rural Municipality Office, Salyan.
- 5.If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day..
